## **EXPIRY OF LISTED OPTIONS - 31 DECEMBER 2014**

We are writing to you as a registered holder of listed options in Galaxy Resources Limited (**Company**) exercisable at \$0.08 each and expiring on 31 December 2014 (**Galaxy Options**).

Notice is given that the final time for exercising the Galaxy Options is **5:00pm (WST) on 31 December 2014.** Each Galaxy Option entitles you to acquire one ordinary fully paid share in the Company (**Share**) at an exercise price of \$0.08 per Galaxy Option.

Your option holding may be exercised in whole or in part by no later than 5:00pm (WST) on 31 December 2014 in the manner set out in this notice. Galaxy Options not exercised by 5.00pm WST on 31 December 2014 will expire and will no longer be capable of exercise. Failure to exercise the Galaxy Options by this date will result in the forfeiture of any rights attaching to the Galaxy Options, including the right to subscribe for Shares at \$0.08 each.

The courses of action available to you as a holder of Galaxy Options are as follows:
