# **Results of General Meeting**

Green Rock Energy Limited (ASX.GRK) ("Green Rock") confirms that all resolutions at today's General Meeting except for Resolution 8 were approved with the resolutions being passed on a show of hands.

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the Corporations Act, we advise details of the resolutions and proxies received, set out in the proxy table on appendix 1.

#### **Resolution 8 Withdrawal**

The company has withdrawn Resolution 8, for the "Approval of issue of securities to Mr Stephen Copulos (or his associates) under the capital raising," on the basis that the Australian Securities & Investment Commission (ASIC) have raised issues with the Independent Expert regarding their Independent Expert's Report.

As a result of ASIC's query, the Independent Expert will be working towards finalising a revised Independent Expert's Report.

In addition the Company is working with its advisors and Lead Manager Cygnet Capital on an updated timetable. The Company will update the market as soon as it has considered the impacts on the timeline and the current prospectus.
