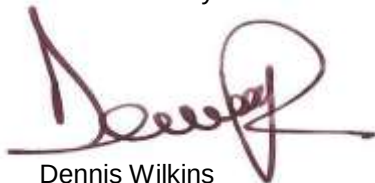
Secondary Trading Exemption
