RCR ANNOUNCES SALE AND LEASEBACK OF PROPERTY

Diversified Engineering and Infrastructure Company, RCR Tomlinson Limited (ASX: RCR) is pleased to announce that it has entered into sale and leaseback arrangements with Heathley Asset Management Limited for three properties and Charter Hall for a fourth property.

RCR Managing Director and CEO, Dr Paul Dalgleish said, "The sale of this property portfolio will reduce our debt levels even further, following the acquisition last year of our Infrastructure business, and also allow us to continue to pursue acquisitional growth opportunities."

RCR is pleased to have both Charter Hall and Heathley Asset Management as owners of these properties.

Net sales proceeds from all four properties will be approximately \$37.5 million, with half of the proceeds to be applied to reducing long-term debt. Financial settlement of all properties will be completed by 23 December 2014.

The sale and leaseback agreements are over the following properties:

11 Abdon Close, Bennetts Green, New South Wales	8 year lease term
5 Ganley Street, Gladstone, Queensland	12 years with a further 3 year option period (exercisable at RCR's discretion)

All leases on these properties are structured on a triple net lease structure with RCR responsible for capital expenditure and repairs to the properties.
