Hammer 2015 Exploration Program

Hammer Metals Limited (ASX: HMX) ("Hammer" or "the Company") is pleased to update shareholders on the Company's forthcoming activities on its Mount Isa projects.


- Hammer intends to build on the achievements of the 2014 exploration program which included new copper resources at Overlander North and Overlander South, drilling of the highest grade molybdenum-rhenium intercept yet at Kalman, as well as defining large Ernest Henry-style Iron Oxide Copper Gold (IOCG) systems at Overlander, Andy's Hill, Dronfield and Hammer Time.
- An extensive exploration program is planned for 2015 with the focus during the first quarter on Overlander, Andy's Hill and Hammer Time.
- A dipole-dipole IP survey at Overlander and Andy's Hill is scheduled to begin in early February.
 The survey will follow on from the exciting results of the 2014 magnetics and gravity modelling
 which defined two zones, both indicative of IOCG systems (ASX:HMX 26/11/2014). The IP survey
 will refine these anomalies and enhance drill target definition. Drilling will commence
 immediately after the IP is complete.
- Drilling will commence at the Hammer Time prospect and then shift to Overlander and Andy's
 Hill once the IP results have been modelled. Hammer Time has a ready-to-drill IP chargeability
 anomaly with coincident surface geochemical anomalism and favourable alteration (ASX: HMX
 14/7/2014).
- Work is scheduled to commence as soon as the current wet season has ended and conditions on the ground are favourable. It is anticipated this will occur during February.

The aim of exploration activities in the first quarter of 2015 will be to further define with IP and then drill the Overlander and Andy's Hill IOCG targets. Existing geophysical anomalies at Hammer Time (located 2km to the west of Kalman) will also be drilled. Detailed structural and alteration mapping will be completed at these prospects whilst the IP survey is underway.


