



UPDATE ON CANINDÉ GRAPHITE PROJECT

Paradigm Metals Limited ("Paradigm" or "the Company") is very pleased to provide an update on its 80% owned Canindé Graphite Project ("the Project") located in Ceará State, Brazil.

The Project comprises approximately 15,614 hectares with exploration licenses granted and several graphite targets already delineated. A diamond drilling core programme has been planned and drilling is expected to commence imminently. The Company has completed exploration activities to support the drilling programme.

Geological mapping over Pedra Preta target has revealed at least two sub parallel graphite rich layers with a gentle dip towards the east. Along these layers, the Company believes there are massive graphite zones that can reach up to 20% of graphitic carbon ("Cg")1.

The initial exploration diamond drilling programme for the Pedra Preta target will comprise five drill holes for a minimum of 420 metres distributed on three separate drill sections (**table 01**) along 400m strike and open from both sides. All drill holes will be angled towards a western direction and the drilling program should be concluded within a three weeks period.
