DECEMBER 2014 QUARTERLY UPDATE

Black Star Petroleum Limited ("**BSP**" or "the **Company**") is pleased to report on its activities for the December quarter.

The Company realised a portion of its investment in The Global Resources Investment Trust Plc ("**GRIT**") through the sale of 107,244 GRIT shares at GBP 0.25 per share. The Company received \$48,609 on settlement of the transactions.

On 24 November 2014, the Company advised Hawkley Oil and Gas Limited (ASX:**HOG**) that it had withdrawn from the terms sheet signed with HOG as announced to the ASX on 14 October 2014. Key conditions precedent to completion were not satisfied and as such BSP elected not to proceed with the transaction.

BSP remains committed to continuing the development of its land holding in Banner Country Nebraska and will be proceeding with other arrangements in due course. The market will be notified of these arrangements as they are finalised.
