### APPENDIX 4C – QUARTERLY CASH FLOW REPORT – DECEMBER 2014

**Adelaide, Australia, Thursday 29 January 2015: Axiom Properties Limited (ASX:AXI)** lodges the attached Appendix 4C Quarterly report for entities admitted on the basis of commitments for the quarter ended 31 December 2014.

Commentary is provided as follows:

- The Company held cash reserves of \$6.93 million at 31 December 2014.
- The Company's cash reserves for the December quarter decreased by \$1.22 million as follows:
  - Net operating cash outflows for the December quarter were \$3.30 million.
  - Net investing cash flows for the December quarter were \$nil.
  - Net financing cash inflows for the December quarter were \$2.08 million.

Operating cash outflows predominately related to the construction and development of the Company's 100% owned Churchill South, a 5,500 sq.m large format retail precinct which was completed in December 2014. The Centre is fully let, is expected to generate a strong cashflow for the Company and complements the strong cashflow the Company derives from the rental income from its 50% interest in its flagship Churchill Centre North Shopping Centre.
