#### **EXERCISE OF OPTIONS**

As announced on 19 January 2015 by ABM Resources NL ("the Company"), 5,550,000 unlisted options, which were shareholder approved on 23 November 2009, were exercised at an option exercise price of \$0.225 per share. The Company announces that 5,550,000 ordinary fully paid shares (**New Shares**) have now been issued as a result of the exercise of such unlisted options. A completed Appendix 3B in respect of the New Shares is attached.
