GCS AWARDED WORKS ON NEW PERTH STADIUM

Construction services group Global Construction Services Limited (ASX: **GCS**) ("**GCS Group**") announced today the Group's contracting division, "**CASC**", has been awarded a \$30 million contract by Brookfield Multiplex to install and supply formwork and concrete at the new Perth Stadium on the Burswood Peninsula. The work to be performed by CASC includes the provision of formwork, concrete supply, concrete pumping, and concrete placement.

The announcement means the foundations of the new Perth Stadium will soon start to take shape with the first concrete slab to be poured by mid-2015 using enough concrete to fill 21 Olympic pools to stabilise the Stadium's five level structure, which will reach a height of 42 metres.

CASC is scheduled to commence work on the project in the coming weeks and will carry out its contract over a period of 12 months.

The 60,000 seat new Perth Stadium will be a world class, multi-purpose venue capable of hosting AFL football, cricket, rugby, soccer (football) and entertainment events.

"The GCS Group has had a successful partnership with Brookfield Multiplex including the recently completed \$2 billion Fiona Stanley Hospital in Murdoch and is pleased to be involved in this world class venue", said GCS Group Managing Director Mr. Enzo Gullotti.

"There is a significant amount of new activity in the commercial sector in Western Australia. This project is the first of a number of major commercial projects to be let and we are anticipating a resurgence in this sector in FY15 and beyond," said Mr. Gullotti.
