### Capital raising and SFP transaction

3D Medical Limited (ASX: **3DM**), previously Safety Medical Products Limited (ASX: SFP), was today reinstated to official quotation on the Australian Stock Exchange ("ASX") following the Company's compliance with Listing Rule 11.1.3 and Chapters 1 & 2 of the Listing Rules. A condition of reinstatement was raising a minimum of \$3.0 million. The Company is pleased to report that it successfully placed 81.8 million new ordinary shares at \$0.05 per share to raise \$4.1 million before costs. The Board of 3DM welcomes the new shareholders to its register.

### Progression of exclusive supply agreement with Capitol Health

3DM and Capitol Health have updated the Exclusive Supply Agreement signed in 2014. The new 5 year agreement will now expire 1 March 2020 and includes agreed service levels typical of agreements of this nature. Capitol Health are a foundation customer of the Company's 3D anatomical printing services and currently generate greater than 1.0 million scans per annum that are capable of being transformed into 3D models.

### Sales of printed models – New Customers

3DM commenced formally pre-selling its 3D printed anatomical models to the broader market in late January 2015 and have invoiced sales in February to four new corporate customers including a research foundation, two manufacturers of medical implants and an orthopaedic practice.

Since completion of the capital raising the Company has commenced commercial discussions with selected potential customers regarding exclusive supply agreements similar to the exclusive supply agreement with Capitol Health.

### New premises

On completion of the capital raising 3DM relocated to standalone premises and operations in Port Melbourne.
