

PROSPECTUS LODGED FOR ENTITLEMENTS ISSUE

Sovereign Metals Limited ("Sovereign" or "Company") is pleased to advise that a Prospectus in respect to the Company's one for five non-renounceable entitlements issue ("Offer") was lodged with ASIC today.

On 24 February 2015, the Company announced that it would undertake the Offer to raise up to \$1.25 million before costs. Under the Offer, eligible shareholders will be entitled to acquire one (1) new ordinary share ("New Shares") for every five (5) ordinary shares held at the record date (being 18 March 2015) at an issue price of \$0.06 per New Share.

The Prospectus together with an Entitlement and Acceptance Form are expected to be sent to eligible shareholders on 23 March 2015.
