DORAY COMPLETES COMPULSORY ACQUISITION OF MUTINY GOLD LIMITED

Doray Minerals Limited (ASX:DRM, Doray, the Company) is pleased to announce that it has completed compulsory acquisition of the remaining ordinary shares and listed options in Mutiny Gold Limited (**Mutiny**) under the compulsory acquisition provisions of the *Corporations Act 2001* (Cth) such that Doray now holds 100% of Mutiny.

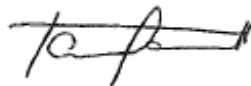
