First Stage of Capital Raising Completed raising \$1,670,817

Gulf Industrials Limited (ASX Code: GLF) is pleased to announce that further to its announcement on 4 March 2015 it has now completed the first stage of its capital raising.

The Company has issued a total of 417,704,390 shares at \$0.004 under the provisions of ASX Listing Rules 7.1 and 7.1A to sophisticated and otherwise exempt investors.

The second stage will be completed following (and subject to) the receipt of shareholder approval which is expected to be in April 2015 which will raise approximately an additional \$1.8m.

The funds raised will enable Gulf to continue to seek exploration opportunities and advance its activities in Africa and for working capital.
