NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

On 19 March 2015, Avita Medical Limited (Company) completed an institutional placement of 81,327,101 fully paid ordinary shares in the capital of the Company (Shares) at a price of \$0.062 to sophisticated and professional investors, raising approximately \$5.04 million.
