YONDER & BEYOND COMPLETES STRATEGIC INVESTMENT IN CONNEXION MEDIA

- Yonder & Beyond invests A\$300,000 in Connexion via the placement of 1.5m shares at A\$0.20 per share

25 March 2015, Melbourne, Australia: Global technology operational accelerator Yonder & Beyond Group Limited ("Yonder & Beyond") (ASX: YNB) has completed a strategic investment in ASX-listed technology company Connexion Media Limited ("Connexion") (ASX: CXZ), a specialist in the connected car market.

The investment of A\$300,000 comes via the purchase of 1.50 million shares at A\$0.20 per share from existing CXZ shareholders. The strategic investment is the first made by Yonder & Beyond since its recent listing on the ASX.

Yonder & Beyond will use its vast technology intelligence and expertise to assist Connexion with sales and marketing opportunities across the Asia Pacific region. Connexion has two core products, the miRoamer radio and music service app for web connected vehicles as well as cloud-based connected vehicle management service Flex.

miRoamer aggregates a variety of leading cloud based content providers to provide a bespoke in-car audio and visual experience for the end-user. Leveraging digital AM/FM radio and podcast services from around the world, drivers can access up to 35,000 stations or customise their content based on genre, language, location and more.

The platform also enables car manufacturers to create branded audio and visual content hubs for the end user, tailoring the user experience accordingly. To date, Connexion has signed deals with Volkswagen, General Motors and Continental for the installation of miRoamer in its infotainment hardware.

Flex provides the ability to manage a fleet of vehicles from a central control point using 3G mobile connectivity. The cloud based platform provides fleet managers with tracking information including vehicle location, distance travelled, fuel consumption and battery life therefore improving productivity, safety and vehicle management.

"We see huge potential in the connected car market and Connexion is at the forefront of opportunities in the sector, it has been on our radar for some time. We bring a wealth of relationships in entertainment technology and services that we feel that we can introduce that will set the products apart and out front" Yonder & Beyond CEO and Managing Director Mr Shashi Fernando said.

"Mr Fernando and his team have proven themselves in the delivery of world- class technologies with a particular focus on mobile and entertainment solutions. Shashi personally brings with him long established entertainment relationships that will quickly feed into the miRoamer offering an exceptional solution for any manufacturer globally," Connexion Media CEO and Managing Director George Parthimos said.
