# **Scheme Booklet Registered With ASIC**

Trafford Resources Limited (ASX:TRF) is pleased to announce that it has received the Federal Court orders approving the convening of the Company shareholders and optionholders meetings to approve the Schemes for the merger of the Company with IronClad Mining Limited (ASX:IFE).

The Federal Court has also approved the explanatory statement (Scheme Booklet), which includes the Independent Expert's Report and Independent Valuation Reports of Trafford's and IronClad's assets for dispatch to Trafford shareholders and optionholders by Thursday, 2 April 2015.

The Company has registered the Scheme Booklet with ASIC.

## **Scheme Meetings**

The Share Scheme Meeting will be held at 10am (WST) and the Option Scheme Meeting will be held at the later of 10.30am (WST) and the conclusion of the Share Scheme Meeting, on 4 May 2015 at Bentleys, Level 1, 12 Kings Park Road, West Perth, Western Australia.

The Scheme Booklet contains important information about the resolutions to be considered at the Scheme Meetings, and Trafford shareholders and optionholders are encouraged to read the Scheme Booklet carefully and in its entirety.

## **Independent Expert's Report**

The Scheme Booklet contains an Independent Expert Report prepared by BDO Corporate Finance (WA) Pty Ltd, which concludes that the Share Scheme is fair and reasonable and in the best interest of Trafford shareholders. It also concludes that the Option Scheme is fair and reasonable and in the best interest of Trafford optionholders.
