NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

On 15 April 2015, Avita Medical Limited (Company) completed a Share Purchase Plan of 18,314,508 fully paid ordinary shares in the capital of the Company (Shares) at a price of \$0.062 to its shareholders, raising \$1,135,500.
