VISCARIA DRILL HOLE VDD 183 INTERSECTS 3.5m at 2.2% COPPER

Highlights

- **VDD 183 has intersected high grade copper mineralisation outside the existing mineral resource area, in a down plunge position at Viscaria D Zone.**
- **Diamond drill hole VDD 183 has returned assays of:**
 - **17.3m at 0.4% Cu**
 - **7.5m at 1.5% Cu, including 3.5m at 2.2% Cu**
 - **9.5m at 0.5% Cu**
- **Drill hole VDD 185, also at Viscaria D Zone, has been completed and intersected a variably copper mineralised altered and ironstone sequence from 404m to 461m (assays pending).**
- **Drill hole NDD 001 at the Nihka target has been completed at 333.3m. The hole is still to be logged and sampled.**

Avalon Minerals Limited ('Avalon' or 'Company') (ASX: AVI) is pleased to announce the assay results from diamond drill hole VDD 183 at Viscaria D Zone.

Assay results include a broad mineralised interval of 57.4m at 0.5% Cu from 543.3m including:

17.3m at 0.4% Cu from 543.3m

7.5m at 1.5% Cu from 577.15m, including **3.5m at 2.2% Cu** from 577.15m

9.5m at 0.5% Cu from 591.5m




Figure 1 –Location of VDD 183, VDD 184, and VDD 185 at the Viscaria Copper Project, D Zone

Drill hole VDD 183 was completed at 621.6m and was drilled at -55 degrees towards 130 degrees (see figure 1 and figure 3). The hole was targeted to intersect copper mineralised ironstone in a down plunge position outside of the existing area of the mineral resource estimate. It intersected a mafic volcanic dominated sequence in the upper 530m of the hole, and then drilled through a 70m thick (downhole thickness) interval of variably altered, sheared and brecciated rock comprising ironstone (magnetite dominated rock), dolerite, and mafic volcanic.




Figure 2 –Location on schematic long section of VDD 183 and 185 at the Viscaria Copper Project, D Zone




Figure 3: Drill hole cross section containing VDD 183 and previously drilled diamond holes

The intervals of mineralisation intersected in this drill hole are outside of the area containing the current estimated mineral resources (see figures 2 & 3). The intersections are approximately 120m down plunge from a previously drilled hole VDD166, which intersected 5.9m at 1.5% Cu and 13m at 1.6% Cu. The true widths of mineralisation in VDD 183 are estimated to be approximately 60% of the downhole widths.

Drill hole VDD 185 has also been completed and intersected a variably copper mineralised altered and ironstone sequence from 404m to 461m. Drill core has been logged, sampled and despatched to the laboratory. Assay results are expected towards the end of May.

Drilling has also been completed on the first diamond drill hole, NDD 001, into the Nihka target, located 2 km south of Viscaria A Zone. The drill hole is a follow up to a bedrock copper anomaly partly co-incident with a 900m x 300m magnetic anomaly, as announced on 9th April 2015. The hole was stopped at 333.3m and is yet to be comprehensively logged, and has not yet been sampled. The hole intersected alteration consistent with an iron oxide copper system and assays are expected in June.

A ground magnetics survey has been completed over several targets in the Viscaria area and results will be reported once the data are processed and interpreted.

Avalon's Managing Director, Mr Malcolm Norris said, "This is an encouraging start to our drilling program to grow the resource estimate at Viscaria D Zone and to focus on the areas of interpreted high grade copper. In addition we are accelerating our near mine exploration effort with drilling at Nihka and definition of further targets that will be drilled in 2015".
