Zambezi Resources Announces \$500k Capital Raising

Zambezi Resources Limited ("Zambezi" or the "Company") is undertaking a pro-rata non-renounceable Rights Issue ("Rights Issue") to eligible shareholders on the basis of one (1) new Zambezi ordinary share ("New Share") for every three (3) Zambezi ordinary shares held as at 5:00 pm (WST) on 28 May 2015 ("Record Date"), at an offer price of \$0.04 per New Share. The Rights Issue will seek to raise up to approximately \$506,000 (before costs).

The Rights Issue is not underwritten and the directors reserve the right to issue the shortfall at their absolute discretion.

The funds raised will be applied for working capital purposes and towards the ongoing funding of the Company's legal challenge of successfully dismissing the appeal and removing the stay of execution that is currently preventing the Company from developing its 100% owned Kangaluwi Copper Project. The need for additional funds has come about largely as a result of the delay in the handing down of the appeal decision that was announced to the ASX on 29 April 2015.

The New Shares will rank equally in all respects from the date of allotment with the existing class of quoted ordinary shares.

Eligible shareholders will receive a copy of the Rights Issue document and accompanying Entitlement and Acceptance form setting out the relevant details.

The Rights Issue closes at 5:00 pm (WST) on 12 June 2015. To participate, you need to ensure that you have completed the Entitlement and Acceptance form and paid all monies before this time and date.
