Issue of Tranche 1 Placement Shares and Notice under Section 708A(5)(e) of the Corporations Act

Continuation Investments Limited ("COT" or "the Company") advises that it has issued 4,875,000 fully paid ordinary shares at \$0.08 per share to professional and sophisticated investors under its 15% placement capacity and additional 10% placement capacity to raise \$390,000 (before costs) (**T1 Placement**).

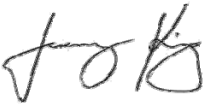
The Company issued the Shares above without a disclosure document to investors under Part 6D.2 of the Corporations Act.
