# ASX ANNOUNCEMENT 1 JUNE 2015

## COKAL, PRIVATE PLACEMENT TO CEDRUS INVESTMENTS LTD

Global metallurgical coal group, Cokal Limited (ASX-CKA), is proud to announce a private placement in the Company to Cedrus Investments LTD (**Cedrus**). The Company will issue Cedrus with 27,777,778 fully paid ordinary shares in Cokal Ltd at a price of A\$0.09 per share, raising A\$2,500,000, before costs. On issue, the placement shares will rank equally with all other ordinary shares then on issue.

The placement will be issued in 2 tranches for general corporate purposes.

The Placement will be completed within Cokal's placement capacity and accordingly no shareholder approval will be sought. The Placement was (as required under Bid Implementation Agreement announced on 29 April 2015) consented to by PT Cakra Mineral Tbk (**CKRA**) and does not change the offer price of their conditional off market takeover bid.

Cedrus manages a global portfolio of proprietary direct investments in China, Southeast and Central Asia, Australia and Africa, primarily in the natural resources, commodities, cleantech and life sciences sectors.

Cokal Executive Chairman Peter Lynch said "the Company was very pleased to have the support of Cedrus. This is ideal opportunity for Cokal to work with Cedrus to expand its shareholder base into Asia."

Cedrus along with Platinum Partners has provide Cokal with a non- binding term sheet to Cokal in relation to a US\$110 million project finance facility for the BBM project as announced on 9 February 2015.

### **PROJECT OVERVIEW**

BBM's Production IUP covers an area of 14,980 hectares (ha), immediately adjacent to BHP Billiton's Juloi tenement. The tenement covers ground which has been zoned as Production Forest. Production Forest zones are areas that have been designated by the Central Government of Indonesia to allow for forestry and mining activities by local and international companies.

The IUP straddles the Barito River and has numerous outcrops of bright coal. Coal core samples analysis confirmed BBM's coal to be a premium coking coal with low ash, low sulphur and ultra-low Phosphorus, as well as Crucible Swell Numbers ("CSN") values generally 9.
