## Amcom Shareholders Vote in Favour of Scheme of Arrangement

At the Scheme Meeting of Amcom Telecommunications Limited ("Amcom") (ASX:AMM) held in Perth today, Amcom shareholders voted in favour of the scheme of arrangement under which Vocus Communications Limited ("Vocus") (ASX:VOC) will acquire Amcom ("Scheme").

Total shares voted at the meeting were 234.7m, with 77.2% voting for, and 22.8% voting against the resolution.

Excluding the interests held by TPG Telecom Limited ("TPG") which voted against the resolution as foreshadowed in its announcement to the market on 30 April 2015, the Scheme received almost unanimous support from the balance of the Amcom share register, with 99.8% of non-TPG votes cast in favour of the Scheme. Of the 181.4m shares voted at the meeting either in person or by proxy other than by TPG, only 0.3m voted against the resolution.

In order for the Scheme to be implemented, the Scheme must be approved by the Federal Court of Australia at a hearing which is scheduled for 11.00 am (Perth time) on Tuesday, 23 June 2015.

Amcom Chairman Mr Tony Grist said, "Amcom shareholders have turned out in force and had their say, with almost every shareholder that voted, other than TPG, voting in favour of the combination with Vocus"

"This shareholder vote is something of a landmark given TPG held 19.99% of Amcom and voted against the Scheme." added Mr Grist.

Full details of the voting results are outlined in the table in Appendix 1 and an indicative timetable and details of the Scheme Consideration are outlined in Appendix 2 of this announcement.

# **Appendix 1: Scheme Meeting Voting Results**

Amcom advises that the resolution to approve the Scheme, as set out in the Notice of Scheme Meeting dated 30 March 2015, was passed by the requisite majority of Amcom shareholders, with:

- 98.7% of Amcom shareholders present and voting (either in person or by proxy) in favour of the resolution; and
- 77.2% of votes cast in favour of the resolution.

### **Appendix 2: Indicative Timetable and Scheme Consideration**

Amcom will now seek orders from the Federal Court of Australia ("Court") for approval of the Scheme at a hearing scheduled for 11.00 am (Perth time) on Tuesday, 23 June 2015.

If the Scheme is approved by the Court, Amcom shareholders registered on the Amcom share register on Wednesday, 1 July 2015 (the "Record Date") will receive 0.4614 new Vocus shares for each Amcom share held at 7.00 pm (Perth time) on the Record Date. Amcom Shareholders will be paid the Scheme consideration on 8 July 2015, in accordance with the terms of the Scheme.
