ASX ANNOUNCEMENT Zanthus Drilling Update

16th June 2015

Rumble Resources Ltd ("Rumble" or "the Company") is pleased to provide an update of the Company's RC drill program at the Zanthus Project in the Fraser Range, Western Australia. Rumble is earning 75% by way of a Joint Venture with Blackham Resources Ltd (ASX:BLK).




Figure 1 &2: Drill Targets – planned Drill Holes into a cluster of 5 bedrock conductors

Rumble has commenced its maiden drill program targeting a cluster of 5 bedrock conductors in and around an eye feature which is in a similar setting to the only known massive Nickel sulphide discovery in the region – Nova Bollinger – **See Figure 1 and 2.**

Rumble's technical team had planned for 5 x RC holes for 1,200 metres targeting a hole at each of the 5 bedrock conductors which may represent magmatic massive Nickel Sulphides. Rumble engaged a DDH1 high powered Sandvick multipurpose RC/Diamond rig providing flexibility with ground conditions.

Rumble has decided to complete RC pre-collars on each of the 5 targets first, to date Rumble has completed 3. Once the pre-collars are completed Rumble will switch to Diamond drilling which will drill through the target zone for all 5 targets. We anticipate the diamond drilling to start sometime later this week. Diamond drilling will provide the technical team with core samples that will aid the technical team post drill program analysis. Rumble will inform the market once it has been completed.

Following the completion of the program a down-hole EM survey will be scheduled to provide a diagnostic test of further bedrock conductors.
