# Secures \$10m Managed & Professional Services Contracts

# **Highlights**

- Empired has successfully secured contracts with a global oil and gas company to provide Infrastructure Managed Services and Professional Services.
- The contracts are for 3 years and will commence during April 2015.
- Empired estimates the value of the contracts to be \$10m in Revenue over the total term of the contracts which includes a fixed monthly managed services fee plus a range of professional services provided for project work.
- The Managed Services contract entails Empired providing a range of infrastructure management services including workplace services, server operations, storage management, database management, network management and service desk for the company's Australian and regional (including offshore) assets, based on a recurring monthly fee.
- The Professional services requires consulting, technical and project management skills plus supply of specialist equipment to support a range of business needs such as new technology deployments or upgrades, establishment of new sites, rig mobilisation or demobilisation.
