POTASH WEST DIRECTOR CHANGE

Potash West NL (ASX: PWN) is delighted to announce a key appointment as it progresses the development of the Dinner Hill project, within the Dandaragan Trough in Western Australia.

Dr Natalia Streltsova has joined the Board of PWN as a Non-Executive Director, effective 30 June 2015. Dr Streltsova is a chemical engineer, with extensive experience in the minerals industry, the last 15 years of which has been in technical leadership roles in major mining houses, such as Vale SA, BHP Billiton and WMC Resources Limited.

Potash West Chairman, Adrian Griffin said "We are delighted that Natalia has joined the Board. Her experience in overseeing project development in the mining industry will be invaluable as we drive to our goal of phosphate production from the Dandaragan Trough. Specifically her exposure to project evaluation in the fertiliser industry will be invaluable."

Concurrently Mr Gary Johnson will step down from the Board, to focus on the development of promising lithium extraction technology. This technology has been developed in conjunction with PWN, which owns 25% of the intellectual property (IP).

Mr Griffin said "Gary has been a Non-Executive Director of PWN since our inception and has been a valuable contributor to our progress. Gary and his team at Strategic Metallurgy have supported our technical development, in particular the K-Max process, owned 100% by PWN. The strong technical support will not be diminished by this step, as Mr Johnson will remain a key member of the technical review group".

"This step will allow a stronger corporate separation between the owner of 75% of the lithium technology, Li Technology Pty Ltd, and Potash West. Both parties remain committed to working together to deliver the value in the K-Max and L-Max technologies."

Mr Johnson said "I am proud of the achievements of Potash West and Strategic Metallurgy, with the process development milestones achieved at Dinner Hill. Building upon the IP of K-Max, we now have an opportunity to unlock significant lithium resources, at a time of unprecedented demand growth. Licencing that technology, will allow several projects to be developed simultaneously, meeting the demands of a rapidly changing world".

About Potash West

Potash West (ASX:PWN) is an exploration company focused on developing phosphate and potassium-rich greensand deposits in Western Australia's Dandaragan Trough. The Company aims to define a substantial resource base and investigate how best to recover phosphate and potash from the mineral. The project is well situated in relation to infrastructure, with close access to rail, power and gas. A successful commercial outcome will allow the Company to become a major contributor to the fertiliser market at a time of heightened demand.

The Company has a major land holding over one of the world's largest known glauconite deposits, with exploration licenses and applications covering an area of more than 2,600 km². Previous exploration indicates glauconite sediments are widespread for more than 150km along strike and 30km in width.

The Company has a 55% interest in 450 km2 of potash exploration licences in a historical potash producing region, the South Harz field in Thuringia, Central Germany. The field has been a potash producer for over 100 years.
