NOTICE OF ISSUE OF SHARES

- i. Barney Bore Exploration Joint Venture Agreement dated 12 July 2015 under which the Company agreed to issue \$20,000 in ordinary fully paid Shares (ASX: KSN) at Volume Weighted Average Price for the previous 5 days (\$0.024) (VWAP), as part consideration for entry into the agreement (Refer Kingston's ASX Announcement on 13 July 2015); and
- ii. Agreement with a media relations consultant under which the Company agreed to issue \$2000 in ordinary fully paid Shares at VWAP for services provided.
