JUNE 2015 QUARTERLY ACTIVITIES REPORT

Haranga Resources Limited ("the Company") is pleased to report on its activities for the June 2015 Quarter.

GRANT OF MINING LICENSE

The Company's 80% owned subsidiary Haranga Khuder LLC, which holds the Mineral Exploration Licenses and Pre-Mining Operations Agreement for its Selenge Iron Ore Project in Mongolia ("the Project"), was granted Mining License #18934A by the Mineral Resources Authority of Mongolia. The license area covers 3,480.70 hectares.

The Mining License is valid for 30 years until 19 June 2045. Pursuant to the Minerals Law of Mongolia, the Company can apply to have the license extended up to 2 additional terms of 20 years each.

As a result of granting of the Mining License, the area covered by Exploration License #11334X has been split and new Exploration License #18935X granted. As such, the Company now holds a total of 5,459.85 hectares that remain valid under the status of the Pre-Mining Operations Agreement as shown in the Figure 1 and Appendix 1.

The remaining 5 tenements as listed at Appendix 1 remain unchanged.

OTHER ACTIVITIES

During the Quarter, the Company's main focus was the progression of the Project, with a focus on the Development Stage in order to enable the Project construction to commence.


At the Annual General Meeting of 2015 was held on 29th of May 2015, Mr. Amarbaatar Chultem was not re-elected as a Director of Board.
