Mining Exploration Entity **QUARTERLY REPORT 30 JUNE 2015**

During the last Quarter ending 30 June 2015, the Board have continued to conduct due diligence on a number of major projects in Australia and overseas with a vision to securing a new project for Dragon Mountain Gold Limited ("DMG" or "the Company").
