Megastar Millionaire Completes Strategic Partnership

Minerals Corporation Limited (the **Company** or **MSC**) is pleased to announce that Megastar Millionaire Pty Ltd (**Megastar**) has concluded a strategic investment in Social Media Studios (**SMS**), a US (Los Angeles, California) 'Pure Play' social media emerging artist studio.

SMS seeks to be the dominant movie studio and platform to connect social media talent with their audiences.

Based in Los Angeles, California, the studio will produce, market and distribute high quality, moderate cost, films leveraging social media audiences and channels, leveraging its portfolio of Hollywood insider talent. Social Media Studios will also create a production & distribution platform that will streamline the process for procuring scripts, digital music rights and casting of talent for managing production teams and distributing talent.

SMS is a "pure play" data driven, Internet and mobile first opportunity. The idea is to create highly predictable and profitable movie releases with extremely low break-even (1% conversion) and the potential to be \$100M+ franchises a la 'The Blair Witch Project' (\$250M gross) or 'Mad Max' (\$100M gross).

Notable talent associated with Social Media Studios include John Baldecchi, an "A-list" Hollywood executive producer with credits including <u>The Mexican</u>, <u>88 Minutes</u> and the remake of <u>Point Break</u>. Mr Baldecchi serves as co-founder and CEO, thereby having an active role in Social Media Studios.
