ANNEX

Skyven Growth Opportunities Fund Pte Ltd ("Skyven") had entered into an agreement with TCJM Holdings Limited ("TCJM") & Highpoint Capital Investment Ltd ("Highpoint") on 7 June 2011. This agreement was made pursuant to services rendered to Skyven in facilitating Skyven's investment into Premiere Eastern Energy Pte Ltd, which was effectively the predecessor company of Premiere Eastern Energy Limited. Under this agreement, Skyven agreed to transfer a number of listed shares to TCJM & Highpoint, upon the successful listing of Premiere Eastern Energy Pte Ltd.

Skyven, TCJM & Highpoint signed another agreement on 31 July 2015 to affirm the details of the transfer. This is the basis of the transfer, which has led to the change in the shareholding of Skyven that requires a notification of change.
