We refer to our previous ASX announcements regarding the Voluntary Administration of the Company, and provide the following update.

## **Outcome of Second Meeting of Creditors**

The Second Meeting of Creditors was held at the offices of KPMG, Level 8 235 St Georges Terrace, Perth, WA, 6000, on Friday 7 August 2015 at 9:30am. At the meeting, creditors of the Company resolved that the Company should execute a Deed of Company Arrangement ("DOCA") in accordance with the terms of a DOCA Proposal which was received by the Administrators providing for the recapitalisation of the Company with the objective of having its shares re-quoted on the ASX.

As contemplated in our previous announcement, the DOCA Proposal is conditional on (amongst other things) shareholder approval, and in this regard, a general meeting of shareholders will be convened in the next few months. Shareholders will receive a notice of the meeting accompanied by an Explanatory Memorandum in due course which will set out (amongst other matters) the terms of the DOCA Proposal.
