### **RESULTS OF SHARE PURCHASE PLAN**

The directors of Catalyst Metals Limited (Company) are pleased to advise that the Company has received applications for a total of 1,453,130 ordinary shares for gross subscription proceeds of \$465,000 from the share purchase plan announced on 11 June 2015. Under the terms of the offer, eligible shareholders were entitled to purchase up to \$15,000 worth of shares, at a subscription price of 32 cents per share.

The directors wish to acknowledge the strong support of shareholders to the share purchase plan offer.
