Further to the ASX announcement dated 11 August 2015, iWebGate Limited ("**iWebGate**"; "**Company**") is pleased to provide an update on its Workspace Suite of network security services which is being offered to customers through the online Apps marketplace.

iWebGate has experienced a strong volume of positive interest in Workspace Suite across Australia from its partners' networks, who onsell the solution to hundreds of thousands of customers. In response to this volume of interest, iWebGate will increase its sales force Australia-wide to support the uptake of WorkSpace Suite. The enlarged sales team will continue to provide technical support to underpin sales of the services.

Commenting on the progress, Mark Harrell, Managing Director of iWebGate, said: "the positive interest that we have received in the first few weeks since iWebGate's WorkSpace Suite went live on the platform is really encouraging. We are delighted to be expanding our technical support and sales team to underpin the demand for WorkSpace Suite."

As previously announced, iWebGate is selling its Workspace Suite of network security services through the online Apps marketplace, powered by AppDirect. iWebGate has a revenue share agreement with AppDirect, a leading global online commerce platform that allows end users to browse, purchase and manage subscriptions to cloud services and applications.

iWebGate is well-positioned to address the growing need for cybersecurity solutions globally with the worldwide cybersecurity market growing rapidly from US\$75 billion in 2015 to US\$170 billion by 2020, according to reports by Visiongain, and Markets and Markets.

iWebGate holds several patents in IT security and network virtualisation, and is a worldwide winner of the Global Security Challenge (US\$300,000 first prize and a contract with the US Government's Technical Support Working Group — Combating Terrorism Technical Support Office). iWebGate is part of Northrop Grumman's Cync Program and recently completed a contract for the organisation, the largest defence contractor in the US and fifth-largest globally with a market capitalisation of US\$32 billion (NYSE: NOC).



As well as these US awards and contracts, iWebGate is also a former winner of Telstra's Australian Innovation Challenge and international winner of the Asia Pacific Information Technology Association's best security product.

Since winning these US and international awards, the problem of inadequate network segmentation and complex cyber security deployments have worsened with the proliferation of cloud and mobile computing. The worldwide cyber security market continues to grow rapidly and is expected to increase from US\$75 billion in 2015 to US\$170 billion by 2020, with iWebGate well positioned to help many enterprises and government agencies.
