

Metal Bank Share Placement

The Board of Metal Bank Limited (ASX: MBK) (*MBK* or the *Company*) is pleased to advise that it has received placement applications from sophisticated investors for the placement of 33,333,333 million shares at 1.5 cents per share representing a 50% premium to the closing price of 1 cent on 7 September 2015 and a discount of 15% to the 30 day Volume Weighted Average Price of 1.77 cents for the Company's shares as at that date.

Placement of 23,333,333 shares (*Placement Shares*) raising AUD\$350,000 has been completed.

The placement of the remaining 10 million shares, raising a further AUD\$150,000 is to an investor associated with the Company's Chair, Inés Scotland and is subject to and conditional on shareholder approval at the next general meeting of the Company, at a date yet to be determined.

The funds raised will be used to fund the Company's working capital requirements and exploration expenses, including continuing the Mason Valley Copper Project exploration program.

The shares issued under the placement were issued pursuant to the Company's 15% placement capacity under ASX Listing Rule 7.1.
