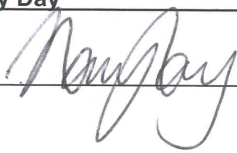

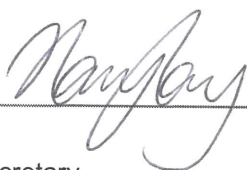

DIRECTIONS

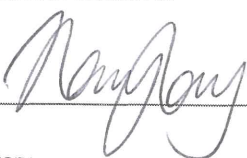
