

# HIGH GRADE GOLD RESULTS CONTINUE FOR TOPACIO

# **HIGHLIGHTS**

- Oro Verde's successful search for new drill targets at Topacio continues with additional high grade gold results from surface sampling
- Extension of Topacio vein to the NE and the adjacent cross cutting Su Majestad vein impress with:

Topacio NE up to 52.4 g/t Au and 158 g/t Ag
 Su Majestad up to 5.1 g/t Au and 25 g/t Ag

- **Solution** 2 Zone to the NW of the Topacio resource area returns additional high grade results:
  - Chicago vein up to 23.8 g/t Au and 41 g/t Ag
- Epithermal vein textures at Rebeca and silicification/brecciation at Buena Vista, combined with anomalous geochemistry, indicate the potential for a broader high level epithermal system on the Topacio concession.

**Oro Verde Limited (ASX: OVL)** ("Oro Verde" or "the Company") is pleased to announce that the most recent sampling from the Topacio Gold Project, located in southeastern Nicaragua (Figure 1), continues to uncover areas of very high grade gold mineralisation.

Surface samples collected from the northeastern extension of the Topacio quartz vein returned very high grades of **52.4** g/t gold (Au) and **158** g/t silver (Ag) from an ore pile associated with artisanal workings, while channel sampling across an *in situ* quartz vein returned **1.1m** at **19.0** g/t Au and **25** g/t Ag.

Samples collected from Su Majestad - a NW trending vein that cross cuts the NE Topacio extension – returned values up to **5.12 g/t Au and 25 g/t Ag**. These sample results support previous assays of up to **14.1 g/t** and **58 g/t** Ag from the same vein<sup>1</sup>

The area to the northwest of the Topacio gold resource has previously been identified by Oro Verde as containing significant potential for high grade mineralisation<sup>2,3</sup>. Our latest sampling followed up an earlier single sample of 7.98 g/t Au and 26 g/t Ag<sup>2</sup> on the Chicago vein, with **excellent new high grades of up to 23.8 g/t Au and 41.1 g/t**.

Oro Verde's Managing Director, Mr. Trevor Woolfe commented, "Excellent high gold grades continue to be received from veins surrounding the existing Topacio resource area – a sample from artisanal workings on the Topacio NE vein extension returned almost 2 oz/t gold. Additionally, the Chicago vein to the northwest of the concession adds to our list of new target areas with surface grades up to 23.8 g/t gold."




Figure 2 Topacio – Mining concession with current sample locations

### **PHASE 7 SAMPLING**

Sampling during the latest campaign essentially covered two zones peripheral to the existing Topacio Gold Project resource area: the Northwest vein zone and the Topacio NE zone (Figure 2). Broader reconnaissance efforts focused on mapping and landowner liaison at the Buena Vista (Figure 2) and




Figure 3 Topacio Gold Project – Latest Oro Verde sampling results

Rebeca areas (Figure 3). All samples were submitted for gold analysis by Fire Assay and multielement (33 elements) analysis by aqua regia digest and ICP.

#### **Topacio NE Zone**

The Topacio vein has a strike length of over three kilometres (Figure 2). Channel samples and grab samples from ore piles associated with artisanal workings (#48611-48615) were collected to the **northeast along the Topacio vein** during this latest sampling phase. Samples from ore piles indicate that high grades, up to almost **2 oz/t Au** have been extracted from the artisanal workings. Additionally, channel sampling across exposed surface quartz veins of around one metre width provide further evidence of the high grade nature of the vein.

Samples collected from the Topacio NE zone included (Table 1):

- Sample 48614 19.0 g/t Au and 25.4 g/t Ag (1.1m channel quartz vein)
- Sample 48615 52.4 g/t Au and 158 g/t Ag (artisanal ore pile see Figure 4)

While the Topacio vein is of significant strike length and trends northeasterly, it is cut in several locations by shorter strike length northwesterly trending veins. One of these is the **Su Majestad** vein with a strike length of approximately 500m (Figure 3). Previously, the Company had collected only two rock chip samples from the Su Majestad vein, with encouraging grades of 4.19 and 14.1 g/t Au<sup>1</sup>. Three new channel samples (#48608-48610) across quartz veins up to 1.4m in width have confirmed the continuity of gold mineralisation with grades ranging from **2.87 to 5.12 g/t Au**.

#### **Northwest Veins**

The veins to the northwest of the Topacio gold resource area (Figure 2) continue to return high gold and silver grades, demonstrating the area's potential for significant gold mineralisation. The zone consists of a number of veins striking in NE and NW directions. While the western end of the Mico vein strikes northeasterly, the Chicago vein cuts it in a west-northwesterly orientation and appears to also disrupt other NE trending veins at Celedonio and Gallina.

An earlier sample from an ore pile on the **Chicago** vein<sup>2</sup> returned a promising result of almost 8 g/t Au. The Company's latest sampling from artisanal workings and also channel sampling across the Chicago vein has reinforced this prospectivity with high grade gold results (Table 1), including:

Sample 48600 21.0 g/t Au and 12.1 g/t Ag
Sample 48601 2.69 g/t Au
Sample 48602 5.40 g/t Au
Sample 48603 23.8 g/t Au and 41.1 g/t Ag
(1.2m channel – quartz vein)
(ore pile – artisanal workings)
(ore pile – artisanal workings)

The complex interplay between these cross cutting veins is still being identified and evaluated by our mapping and sampling activities, however the presence of high grade gold results strongly suggests the existence of high grade shoots in dilational settings related to the intersections of these cross cutting veins.

#### **Buena Vista and Rebeca**

Oro Verde believes that the 9,300ha Topacio Gold Project has the potential to contain a multi-million ounce low sulphidation epithermal gold system. This belief is based on the existence of epithermal vein textures (for example at the **Rebeca** vein) and geochemistry across the broader concession area that indicates the possibility for a deeper buried system, particularly to the east of the existing Topacio gold resource area.

The two samples collected from Buena Vista (Figure 2) and Rebeca (Figure3) during the latest campaign returned low grade (but anomalous) gold values (Table 1), significantly higher Ag:Au ratios and elevated Ba values. The **Buena Vista** area offers a potentially new deposit style with mineralisation encountered to date associated with a stockwork of quartz veinlets within altered volcanic host rocks.

## **BACKGROUND**

On 25 February 2015, Oro Verde announced the positive due diligence and acceptance of an Option to Purchase Agreement over the high grade Topacio Gold Project, located in southeastern Nicaragua (Figure 1). The project boasts a historical NI 43-101 (Canadian standard, similar to JORC) compliant Inferred Resource of:

2,716,176 tonnes at 3.9 g/t gold, containing 340,345 ounces of gold, at a 1.5 g/t gold cut-off 4.

National Instrument 43-101 ("NI 43-101") is a national instrument for the Standards of Disclosure for Mineral Projects within Canada and as such this estimate is a foreign estimate and is not reported in accordance with the JORC Code. A competent person has not done sufficient work to classify the foreign estimate as mineral resources in accordance with the JORC code and it is uncertain that following evaluation and/or further exploration work that the foreign estimate will be able to be reported as mineral resources in accordance with the JORC code.
