Terms of employment of Executive Director

In accordance with ASX Listing Rule 3.16.4, The Company makes the following disclosures in respect of the key terms of the executive services agreement entered into with its new Executive Director, Mr Colm O'Brien.

Terms of the Appointment

The services agreement has a term of 6 months which will be deemed to commence from 1 September 2015. The agreement can be extended by mutual agreement.

Remuneration

The remuneration payable to Mr O'Brien will be

- 1. A directors' fee of \$54,750 inclusive of the minimum statutory superannuation contributions.
- 2. A monthly service fee of \$10,438 inclusive of the minimum statutory superannuation contributions.
- 3. 1 million options to acquire shares in Pacific Star Network Limited at an exercise price of 30 cents per option vesting on the date that is 6 months after the commencement of Mr O'Brien's service agreement and expiring 3 years after the commencement of Mr O'Brien's service agreement.

Directors' have resolved to seek shareholder approval for the issue of share options to Mr O'Brien, at the forthcoming Annual General Meeting to be held on 27 November 2015.

Subject to receiving the appropriate shareholder approval, directors' will issue the share options.

Mr O'Brien's remuneration package will be reviewed 6 months after commencement of the service agreement.

Termination

- 1. Either party may terminate the agreement at any time and for any reason by giving the other party 30 days' notice in writing.
- 2. In the event that the Company terminates the agreement, the fee payable will be the reminder of the fee due for the remaining period of the 6 month services.

Restraint

The services agreement includes provisions to restrain Mr O'Brien for a period of up to 6 months following the cessation of the services contract, from soliciting, customers, suppliers or employees of the Company.
