ALLOTMENT OF SHARES UNDER EMPLOYEE SHARE PLAN

As approved by shareholders at the 2013 Annual General Meeting ("AGM"), the board of directors advises that it has granted shares to various employees under the approved Employee Share Plan ("ESP").

The principal terms of these grants are:

- (a) Total grant of 4,800,000 shares;
- (b) An allotment share price of 5.0 cents per share;
- (c) As provided for under the ESP, a non-recourse loan attaching to and secured by the shares;
- (d) Principal terms of the loans, being interest free with a two year term; and
- (e) Vesting condition of the shares, being that the employee must remain employed with the Company (or associated body corporate) for two years after the date of allotment of the shares.

Full details of the ESP and loan terms are available on the ASX in the 2013 Notice of AGM.

The company has engaged an independent valuer to assess the value of the issue of these shares, attaching loan and related conditions, with an implied valuation of 0.5684 cents per share (or \$27,283 in total on 4.8 million share grant).

In determining the share price for the allotment under the ESP, although the ESP allows for the issue of shares at a price of no less than the volume weighted average price at which Shares were traded on the ASX over the 10 trading days up to and including the actual date of acceptance of the Shares offered under the offer, the board has determined that the share price should be set at a multiple of the current price. The board has also taken into consideration the last price that capital was raised in the Company, being 5.0 cents on 29 April 2014. Based on the closing price of 9 September 2015 being 1.4 cents per share, the grant price of 5.0 cents is over 3.5 times the current share price.

An Appendix 3B advising of the abovementioned grant is attached to this release.

The Company also wishes to advise that at the upcoming 2015 AGM, the Company is proposing the allotment of 1,000,000 shares each to two directors (Mr Hatchman and Mr Franks) under the ESP, at the same price as granted to the employees today. The value attaching to these



allotment to each director based on the recent September 2015 valuation is \$5,684. The Company, as required under the Listing Rules, will be seeking shareholder approval for undertaking these allotments. Full details will be provided in the Notice of Meeting for the 2015 AGM in due course.
