**ISSUE OF SHARES – SECONDARY TRADING NOTICE - NOTIFICATION PURSUANT TO  
PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("Act")**

On 14 September 2015, Rewardle Holdings Limited ("**Company**") issued 150,000 fully paid ordinary shares at an issue price of \$0.20 each ("**Securities**") to an employee on exercise of staff incentive options.
