Secures \$12M Managed Services Contract with Western Power

- Empired has successfully secured a managed services contract with the Electricity Networks Corporation (Western Power).
- The managed services contract is for a term of 7 years, structured as an initial 3 year period with a further two 2 year options.
- Empired estimates the value of the contract to be approximately \$12M in Revenue over the term.
- Transition services under the contract are complete and operational services have commenced.
- Under the contract Empired will provide managed services for all of Western Powers corporate Information Technology networks across Western Australia.
- In addition to managed services Empired will be required to provide a range of project services for the enhancement and development of network infrastructure to support Western Powers business objectives.

Western Power is a Western Australian State Government owned corporation with the purpose of connecting people with electricity in a way that is safe, reliable and affordable. Western Power build, maintain and operate the electricity network in the south west corner of Western Australia. The Western Power Network forms the vast majority of the South West Interconnected Network (SWIN), which is an isolated, self-contained network covering a very large area of 261,000 square kilometres in Western Australia.
