I enclose an amended Appendix 3X (Initial Directors Notice) for John Young who was appointed an alternate director of the Company on 8 July 2015 and as full director on 4 September 2015.

Mt Young has beneficial interests in two entities the Forever Young Family A/C and the Forever Young Superannuation Fund. He understood his accountant had arranged for all holdings to be transferred from issuer sponsored holdings onto Chess and reported the respective number of shares on the Chess accounts as his holdings for the Appendix 3X.

During the course of preparing the Annual Report we have noted that there were still two issuer sponsored holdings that had not been transferred onto Chess and had been omitted from the Appendix 3X lodged on 9 July 2015.

At the time of the original lodgement, I was on annual leave overseas and as the secretarial support staff did not have access to online registry, the usual verification procedures used were not undertaken.
