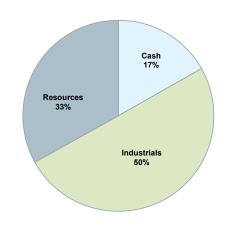

- Bonus option issue completed during the month.

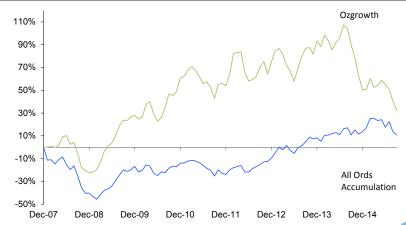
