PLACEMENT UPDATE

Pacific Ore Ltd ("**Pacific**" or "**Company**") is pleased to announce that it has now completed the first tranche of its previously announced placement of 110 million shares at \$0.007 each to sophisticated investors to raise gross proceeds of \$770,000 ("**Placement**").

The first tranche of 81,950,000 shares was issued today using the Company's existing 15% capacity under Listing Rule 7.1. The remaining tranche of 28,050,000 shares will now be issued following shareholder approval at the Company's upcoming Annual General Meeting, rather than using the Company's additional 10% capacity under Listing Rule 7.1A as previously advised.

The Placement has been arranged by CPS Capital Group Pty Ltd ("**CPS**") who have been appointed as Lead Manager and Broker for the Placement and as Corporate Advisor to seek to introduce potential assets that the Company may be interested in acquiring and to provide general ongoing corporate advice to the Company.

Funds raised from the Placement will be used for working capital requirements and to enable the Company to continue its efforts on the identification and acquisition of new business opportunities, both domestically and overseas.
