### THE NEXT PHASE OF DEVELOPMENT TO BE CARRIED OUT BY BADIMO AND KINETIKO IN THE AMERSFOORT PROJECT

- The South African regulatory authority has granted the approval to develop a further 8-wells in close proximity to KA-03PT in the Amersfoort Project.
- The renewal of ER56 and ER38 has been granted in the Amersfoort Project.
- The granting of these approvals enables third party investments in the Amersfoort project.
- The 'Bulk Sampling Permit' allows for the sale of gas and the commencement of the monetization of the project.

Kinetiko Energy Limited (ASX: KKO) ("Kinetiko") with its major shareholder Badimo Gas (Pty) Ltd ("Badimo") in Afro Energy (Pty) Ltd ("Afro") is pleased to announce that the next phase of development in the Amersfoort Project is ready to commence following the granting of:

- The development of a 10-well gas field in Area 1 of ER56 (figure 1) ; and
- The renewal of exploration right ER56 and ER38 for a further two years.

It is planned to develop a 10-well gas field in Area 1 of ER56 in close proximity to KA-03PT. The completion of such a 10-well field requires the approval of an additional well. It is further planned to secure the approval of an additional 8 appraisal/production wells in conjunction with two zone isolation wells in Area 4 of ER56 in close proximity to KA-02C (Figure 1).
