Anatolia Energy Limited – Scheme of Arrangement entered into with Uranium Resources, Inc.

Description

Shareholders of Anatolia Energy Limited (the "Company") voted in favour of the Scheme of Arrangement (the "Scheme") giving effect to the acquisition by Uranium Resources, Inc ("URI"), of all the shares in the Company not already held by URI at a general meeting of the Company held on 9 October 2015.

The Federal Court of Australia approved the Scheme on 22 October 2015.

The consideration is as follows:

- Company Shareholders will receive 0.06579 Uranium Resources Shares for every Company Share held at 7:00pm WST on the Record Date ("Share Exchange Ratio"). Each Share will be rounded up if a factional entitlement is equal to or greater than one half and rounded down if the fractional entitlement is less than one half.
- Company Shareholders will receive Shares in the form of Share CDIs unless a Company Shareholder elects to receive URI Shares.
- Company Shareholders will receive such number of URI Options on substantially the same terms as the terms of their Company options other than an adjustment to the exercise price in accordance with the Share Exchange Ratio as would have a Black-Scholes value for each Company Option they own as at 7:00pm WST on the Record Date.
- Company Performance Shareholders will receive 1 URI performance share on substantially the same terms as their Company performance shares other than an adjustment to the number of URI shares to be issued upon conversion of the URI Performance Shares in accordance with the Share Exchange Ratio for each Company Performance Share they own as at 7:00 pm WST on the Record Date.
