Adelaide, Australia, Wednesday 28 October 2015: Axiom Properties Limited (ASX:AXI) lodges the attached Appendix 4C Quarterly report for entities admitted on the basis of commitments for the quarter ended 30 September 2015.

Commentary is provided as follows:

- The Company held cash reserves of \$5.952 million at 30 September 2015.
- The Company's cash reserves for the September quarter increased by \$122,000 as follows:
 - Net operating cash outflows for the September quarter were \$3.821 million.
 - Net investing cash outflows for the September quarter were \$36,000.
 - Net financing cash inflows for the September quarter were \$3.979 million.

The majority of the operating cash outflows for the quarter related to development (\$3.267 million) and interest costs (\$298,000) on Churchill Centre South and North Stage 3.


