CONTRACT WINS AND STRATEGIC UPDATE

Contract Wins

Diversified Engineering and Infrastructure Company, RCR Tomlinson Ltd (ASX: RCR) today announced it has won in excess of \$100 million in project awards. The successful tenders include preferred contractor for a three year maintenance and shutdown contract for Eraring Power Station for Origin Energy for approximately \$18 million per annum, totalling \$54 million and \$48 million of water infrastructure projects in Western Australia.

The addition of Eraring Power Station to our energy maintenance contracts increases our work at existing power stations; NRG Power Station at Gladstone, Liddell and Bayswater Powers Stations in the Hunter Valley, Millmerran and Condamine Power Stations in Queensland, Northern Power Station at Port Augusta and Torrens Island Power Station. The recent win added to the existing work positions RCR as one of the largest Power Station maintenance and shutdown contractors in Australia.

Strategic Update

RCR retains a strong order book of over \$935 million and is experiencing a significant increase in the major projects pipeline with tendering activity in all our sectors. The strongest activity is in Rail, Transport, Power Stations and new Mining projects. Infrastructure spend is expected to gain momentum in the second half of this financial year and as a result RCR expects revenues to remain flat for the first half and earnings to be biased to the second half of the financial year.

Managing Director's Comments

RCR's Managing Director, Dr Paul Dalgleish, said "added to our healthy order book these contract wins will contribute to building our revenues for the second half of this financial year and help to further diversify our Western Australian business. The growing pipeline of Rail Infrastructure, Power Station and Mining projects continues to support our aspirations for revenue growth next year".
