- New number plate recognition software developed and deployed across 66 sites calendar year 15. A further 125 sites in the pipeline




#### Q1 FY15 v Q1 FY16 Smart Parking Group



- \$2.6m revenue increase in Q1 FY16 from Q1 FY15
- **31%** revenue increase year on year **53%** including FX impact
- \$1.6m EBITDA improvement year on year






#### Continued Technology Implementation

- New ANPR linked with P&D technology developed and deployed.
- 40 sites upgraded with ANPR technology since January 15. An additional 26 installed since August.
- 36 contracted sites to be delivered in Q2.
- More than 100 sites in the prospects pipeline for Q3 & Q4 and beyond.

#### **New Contract Wins**

- Matalan contract retained through competitive process in 2014 – expanded in 2015 from 28 sites to 88 with focus on technology.
- Omniplex Cinema group signed with 11 new sites – technology focus.

- Lidl Supermarkets 38 sites won in Northern Ireland on a 3 year contract – ANPR being installed across the estate.
- Added sales resource are winning new sites monthly.











- Transport for London contract won installation complete – revenue recognition in the same period – 1,585 sensors across 29 underground station car parks.



#### **SUMMARY**

- SPZ continue to lead the world in the development of intelligent car parking solutions for cities around the globe and technology led Parking Management Services in the UK.
- Financial results for FY15 in technology are below expectation but the pipeline is strong and we see no sign of the market opportunity diminishing.
- FY15 H2 results in the services business are strong and re-enforce the message of the continued turn around in the Managed Services Business. SPZ expects this trend to continue with FY16 Q1 numbers showing the continued improvement and validates the technology roll out strategy.
- 66 sites installed with ANPR technology since January 15 with over 100 in the pipeline.
- New projects from Transport for London, Milton Keynes, Cardiff, Westminster along with significant opportunities across all operating markets show the technology is validated and being adopted in the global market place.
