Mr Tsiolis has been a member of several investment and corporate advisory committees including Macquarie Global Infrastructure Funds, Rosemont Partners, Direct Investment Fund, Deutsche Private Equity, Military Superannuation, Citic China Mezzanine Investment Fund and Energy Investors Group. Mr Tsiolis has overseen a number of investments from start up to IPO in the technology sector.

Prior to SCML, Mr Tsiolis served as the Head of Research at ipac Securities. He was also a Senior Investment Analyst of ASSIRT Investment & Technology and a quantitative analyst of James Capel Australia Ltd. Mr Tsiolis is a Governor of the Archeological Institutue in Athens and former deputy chairman of North Asian Strategic Holding Limited

Ms Foster and Mr Tsiolis join the Board at an important stage of growth for iWebGate. Both will provide strategic advice to optimise its cybersecurity services offering, help drive sales and expand its customer footprint in key geographies such as Europe and the US.
